

Leasehold Flats Refurbishment

Work to refurbish the next two blocks on our programme (5-15 Siabod and 70-80 Garnedd)

will commence in September and should be completed by the end of February 2019

The contract has been awarded to W F Clayton of Bangor, who also carried out the first phase of the refurbishment works. We have been very pleased with the quality of the work which was carried out by the Contractor and also the way in which they worked hard to minimise disruption to the residents during the works.

The works to be carried out will be similar to that already done to the first two blocks; clearing out mortar droppings from the cavities, replacement of corroded wall ties,

replacement of defective windows, installation of damp proof courses around window openings and replacement of defective lintels, re-slating and insulation of roofs including necessary roof repairs and new fascia boards together with new gutters and rain water down pipes.

I am sure that everybody who has looked at the two newly refurbished blocks can see that the refurbishments have been done without changing the general appearance of the estate and that they look (and should perform) like new again.

Following the meeting held with the Leaseholders in March, the Board decided that the refurbishment programme would continue, but at a slower rate of progress, consistent with keeping the refurbishment element of the Service Charge at the same level as for the past three years, rather than increasing the annual charge to speed up the programme. It has not been possible to obtain outside finance to allow the programme to be carried out at a faster rate

What the site office does (with only two members of staff and all in 4 hours per day)!!

- 1. Monitoring of the Sea wall, overseeing repairs
- 2. Monitoring service charge payments
- 3. Chasing debts, Unfortunately there are a few although only small in number who become debtors, these owners take up a disproportionate amount of office time, including the need to prepare reports and documentation for the solicitors who act on behalf of the company in pursuing non payment, and in recent years attending court on the cases that have required taking that far, the company is however pleased that all debts have been recovered.
- 4. Preparation of information for the budget
- 5. Production of all information for the year end accounts
- 6. Receipt and banking of money
- 7. Paying contractors
- 8. Overseeing maintenance
 - a. Grounds maintenance (grass cutting etc)
 - b. Gardeners work program
 - c. Maintenance schedules of leasehold properties (monitoring Contractors)
 - d. Tendering and arranging for work required
 - e. Road repairs
 - f. Meeting with dock owners bridge issues
 - g. Liasing with Council on such things as waste removal
 - h. Drainage systems
 - i. Trees, surveys, maintenance
- 9. Recently, design and tender of CCTV system
- 10. Abandoned cars

This involves lengthy correspondence with DVLA to find out ownership, then writing and posting notes to cars, then the Council, finally if no response arranges for its removal (it is important that the company does not end up responsible)

- 11. Checking of the emergency lighting and arranging repairs
- 12. Replying to solicitors on behalf of the Company regarding house sales and queries, LP1, service charge apportionment, stock transfer, land registry, past accounts etc
- 13. Replying to general queries and questions from owners, tenants and visitors
- 14. Monitoring arranging repairs of TV system
- 15. Insurances
- 16. Liasing with hotel owners
- 17. Preparation for board meetings (production of info such as financial position to date, debtors, reports, bank balances, managers report, maintenance update, health & safety) attendance at meetings.
- 18. Maintenance of items such as risk assessments, asbestos reports, fire risk assessments
- 19. Preparation for AGM, booking and checking of venue, production of materials, packs to share holders
- 20. Site Rules
- 21. Overseeing refurbishment program scope of work, monitoring, answering queries from builders, information to owners, overseeing finances, meetings with project manager and contractor

Coastal Path

The section of the path into Parc Faenol was opened in June, despite continuing action from the owners of Glan y Mor Lodge to stop progress. All residents can once again walk through the gateway in to the Parc and enjoy the walk alongside the Menai Straits under the Britannia Bridge to Telford's Menai bridge.

The new section of the Path up from the dockside to Ffordd Glyder is now finally completed and open to walkers. Landscaping including shrub and tree planting will be completed later in the Autumn.

A new sign is to be erected at the entrance to the Estate, making it clear that parking on the estate is for residents and their guests only.

The Board will be monitoring the possible illegal parking by non-residents who want to walk in to Faenol, and also those who ignore the Coastal Path signage and walk along the grassed seafront, which is private and for the enjoyment of our residents only. If necessary further restrictions will be proposed for your agreement and approval.







Charley's Woods. - Sex, Sorrow and a Spiritual Quest in Snowdonia
